Request For Proposal (RFP) Release Schedule JPS Repurposing Initiative

Jackson Public School District (“JPS”) is pleased to announce a schedule for public Requests for Proposals (RFP) commencing May 15, 2024. This information included herein has been provided to notify individuals and groups interested in redeveloping one or more of the inactive school properties listed below as part of the **JPS Repurposing Initiative**.

The RFP will facilitate a thorough review by JPS to identify those with legitimate interests and the capacity to submit a formal project proposal for approval consideration. Consistent with the requirements stated therein, proposal interest forms submitted in response to the **RFP, via email at repurpose@jackson.k12.ms.us**. Proposals will be reviewed on a recurring basis, the third Wednesday of every other month beginning July 17th, 2024.

Following the RFP submissions, selected respondents will be notified if JPS determines the submission as acceptable to move forward to the next phase of the review process.
