4. To provide resources, support services, and educational opportunities for parents and families to enhance their capacity to support their child's learning and development.

5. To celebrate and recognize the diversity of our school community, valuing the unique contributions and perspectives of parents, families, and students.

#### Proposed Policy Components

#### **1.** Communication and Outreach:

- Implement stronger communication channels such as mandated monthly newsletters (specific to each school), emails (regularly updated addresses), and social media updates (all platforms including the local news station) to keep parents and families informed about school events, policies, and student achievements.

- Conduct outreach efforts to engage all families, including those from diverse cultural and linguistic backgrounds, ensuring information is accessible and inclusive. (Thematic Units on our district's core values.)

2. Academic Support and Resources: (Parent Center) Stronger policy that requires activities with our Stakeholders (i.e., Magnificent Mondays, College Turn-Out Tuesday, W.O.W. Working on the Work (ways to help our scholars excel), Thriving Thursdays

- Provide resources and workshops for parents and families on topics such as homework assistance (Paper training), college and career planning, and navigating educational systems.

- Offer access to tutoring services, academic counseling, and intervention programs to support students who may be struggling academically.

### **Collaboration and Partnerships**

Collaboration and Partnerships:

- Foster partnerships with community organizations, businesses, and local agencies to provide additional resources, services, and opportunities for students and families.

- Collaborate with **mandated** parent-teacher associations (PTSAs), school advisory boards, and Superintendent Parent Advisory Board, feedback, and suggestions for improving parent and family engagement initiatives.



### **Evaluation and Review**

Regularly evaluate the effectiveness of the Parent and Family Engagement Policy through surveys, focus groups, and data analysis (Comprehensive Needs Assessment.)

- Review feedback from parents, families, students, and staff to identify strengths, areas for improvement, and emerging needs.
- Make adjustments and revisions to the policy as necessary to ensure it remains responsive to the evolving needs and priorities of the school community.



### Addendum to the Policy: Incentives, Celebrations, and Recognition

#### Incentivizes parents according to a tiered level of participation: Bronze, Silver, Gold, Platinum, and Diamond Life

This policy addendum is intended to embody a sense of accomplishment not only within our scholars but with our parents as well. By implementing a reward system to highlight the participation in a schools organized events, we will celebrate students AND parents achievements, cultural diversity, and involvement, thus creating opportunities for parents, families, and students to come together and celebrate successes.
