- II. Establishment of a Quorum: A quorum was established as four members were seated and Ms. Kimberly L. Campbell was participating via teleconference. Ms. Camille Simms and Mr. Kodi Hobbs were tardy.
- III. Adoption of the Agenda: The Board voted to adopt the agenda as presented, on motion of Dr. Richard Lind and second of Mr. Jed Oppenheim. Section G of the Policy, describes how staff members can express their grievances; next, the school superintendent's policy states that each school district must have a superintendent.

- b. Policy CCA: Outlines duties of a superintendent; the superintendent is the CEO of a district and administers rules and regulations and policies to the board.
- c. Policy CC: Evaluation of the Superintendent in the language of the MSBA, the evaluation of a superintendent must be data driven and will determine how his/her contract is written.
- d. Policy CCD: Tracks language in the law that does not require a nonrenewal hearing of the superintendent. The Separation of School Personnel: a certified employee's departure route differs from a classified employee's route of departure.
- e. Time schedule: the building principal is the instructional leader and is expected to be at the school when necessary. If there is no asst. principal, the principal must appoint someone to act in his/her absence.

These proposed policies were offered for information. Meanwhile they will be placed in public venues for review and public comment. At the end of the publication period, proposed policies will be returned for board approval.
