XIII. Other Business:

XIV. Consideration to Hold an Executive Session: Dr. Luckett moved, and Letitia Johnson seconded the motion, to close the meeting to consider entering into executive session. All 7 board members voted in favor of the motion.

After discussion, Dr. Luckett moved, and Letitia Johnson seconded the motion, to enter into executive session to discuss (1) a proposed settlement of the Jessica Parker bus accident claim; (2) to hear from A. Morningstar, a former district employee, regarding his former employment and litigation he subsequently filed against the district; (Mr. Morningstar had signed up to address the board during public participation, but was moved to executive session because of the nature of the issues he wanted to report to the board.) and (3) to discuss Personnel Item, E.18, the superintendent's recommendation of employment of Dr. Michael Cormack as transition officer/chief of staff. All 7 board members voted in favor of the motion.

The board attorney announced to the public the reasons for entering into executive session.

In executive session, the board first heard from Mr. Morningstar regarding his employment claims and damages sought in his lawsuit against the district. The board heard from Mr. Morningstar, but took no action. The matter was referred to Dr. Greene for further investigation and recommended action.

Next, District Counsel, JoAnne Shepherd, updated board members on the status of the claim of Jessica Parker arising from an accident in which a district bus rear-ended her vehicle. Attorney Shepherd recommended that the board settle the claim for \$19,642.89. Upon discussion, Dr. Luckett moved, and Letitia Johnson seconded the motion, that Attorney's Shepherd's recommended settlement be approved. The motion was unanimously approved.

Finally, Dr. Greene provided the board information regarding the recruitment process, the various candidates interviewed and the qualifications and competence of each, all leading to his recommendation of Dr. Cormack for the position. After questions and discussion, Dr. Luckett moved, and Barbara Hilliard seconded the motion, to approve the recommendation. All 7 board members voted in favor of the motion.

There being no further business to discuss in executive session, Dr. Luckett moved, and Letitia Johnson seconded the motion, to exit executive session. All 7 board members voted in favor of the motion.

Upon returning to open session, Dr. Luckett moved, and Letitia Johnson seconded the motion, to adjourn the meeting. That motion was unanimously approved.
